## **CLIENT CHALLENGES**

- » The client is a leading US-based PE firm investing globally. Our partnership with the client started in 2008, with 8 FTEs supporting 1 fund, which has now grown to 32 FTEs supporting 5 funds
- » A significant portion of the client's in-house resources were allocated to intensive research and analysis tasks, diluting its focus on critical and high-value tasks
